Travel Insurance Coverage

Trip Cost Trip Cancellation/150% of Trip Cost Trip Interruption: Reimburses pre-paid nonrefundable expenses if you must cancel or interrupt your trip due to unforeseen: • Sickness, injury, or death of you, an Immediate Family Member, traveling companion, or business partner. Injury or Sickness must be so disabling as to reasonably cause a trip to be canceled or interrupted; • Financial Default of an airline, cruise line, or tour operator resulting in the complete cessation of services. This coverage applies only if: (1) you purchased this coverage within 15 days of initial trip payment; and (2) the Financial Default occurs more than 14 days after your coverage effective date; • Termination of employment or layoff affecting you or your traveling companion; must have been with the same employer for at least five continuous years; • Inclement weather causing delay or cancellation of travel; • Strike resulting in the complete cessation of travel services at the point of departure or destination; • Your principal residence or destination being made uninhabitable by fire, flood, vandalism, burglary, or natural disaster; • You or your traveling companion being subpoenaed, required to serve on a jury, hijacked, or quarantined; • Being involved in or delayed due to a traffic accident en route to departure; • You or your traveling companion being called into active military service or having leave revoked or being reassigned; • You or your traveling companion being the victim of a felonious assault within 10 days prior to his/her trip departure date; • A terrorist incident in a City listed on your itinerary within 30 days of your scheduled arrival. "City" means an incorporated municipality having defined borders and does not include the high seas, uninhabited areas, or airspace.

"Domestic Partner" means an opposite or a same-sex partner who is at least 18 years of age and has met all of the following requirements for at least 6 months: (1) resides with you; (2) shares financial assets and obligations with you. The Insurer may require proof of the Domestic Partner relationship in the form of a signed and completed Affidavit of Domestic Partnership.

"Financial Default" means the total cessation of operations due to insolvency, with or without the filing of a bankruptcy petition by a tour operator, cruise line, or airline provided the Financial Default occurs more than 14 days following your effective date for the Trip Cancellation Benefits. There is no coverage for the Financial Default of any person, organization, agency, or firm from whom you purchased travel arrangements supplied by others.

"Immediate Family Member" means you or a traveling companion's spouse, Domestic Partner, child, spouse's child, daughter-in-law, son-in-law, brother, sister, mother, father, grandparents, grandchild, step-brother, step-sister, step-parents, parents-in-law, brother-in-law, sister-in-law, aunt, uncle, niece, nephew, legal guardian, caregiver, legal ward, or Domestic Partner of any of the above.

"Sickness" means an illness or disease diagnosed or treated by a physician. **\$1,000 or 150% of Trip Cost Trip Interruption – Return Air Only:** Reimburses the additional transportation expenses incurred by you to the return destination, up to the Maximum Limit shown on the Schedule of Benefits. However, the benefit payable above will not exceed the cost of economy airfare (or first class if your original tickets were first class) by the most direct route, less any refunds paid or payable.

\$1,000 Trip Delay: Reimburses up to \$200 a day to the Maximum Benefit shown on the Schedule of Benefits for reasonable, additional meals, accommodations, taxi fares, and essential phone calls, if your trip is delayed for more than 5 hours for covered reasons.

\$500 Missed Connection: Reimburses this benefit up to the Maximum Limit shown on the Schedule of Benefits if inclement weather or common carrier causes cancellation or a delay of regularly scheduled airline flights for three to less than five hours to your point of departure.

Baggage Insurance Coverage

\$2,500 Baggage & Personal Effects Benefit: Reimburses for loss, theft, or damage to your luggage and possessions, even if borrowed or rented. Covers loss of all passports, visas, and unauthorized use of credit cards if you have complied with the credit card conditions, subject to the Maximum Benefit.

\$500 Baggage Delay Benefit: If your baggage is delayed more than 24 hours while on a trip, you will be reimbursed for the purchase of essential items, subject to the Maximum Benefit.

Emergency Medical & Other Insurance Coverage

\$50,000 Medical Expense Benefit: Pays medical expenses within one year of any injury or Sickness occurring on the trip provided initial treatment was received during the trip. Medical and surgical treatment by a licensed Physician; professional nursing, hospital, x-ray, and ambulance services. Emergency dental treatment up to \$500 by a licensed dentist, only during the trip.

\$1,000,000 Emergency Medical Transportation: Covers evacuation and transportation as directed by a physician to the nearest adequate medical facility (home in the event of death or if medically required).

\$50,000 Accidental Death & Dismemberment: Pays for loss of life or limb if it occurs within 365 days of an accident during your trip.

Cancel for Any Reason: Provides reimbursement of 75% of trip cost if you decide to cancel for any reason up to 48 hours prior to departure.

Cancel for Work Reasons: For travelers who want trip cancellation and interruption coverage in the event they must cancel due to business-related reasons.

PRE-EXISTING MEDICAL CONDITIONS EXCLUSION:

The Insurer will not pay for any loss or expense incurred as the result of an Injury, Sickness, or other condition of you, a traveling companion, business partner, or Immediate Family Member which, within the 60-day period immediately preceding and including your coverage effective date: first manifested itself or had symptoms which would have prompted a reasonable person to seek diagnosis, care, or treatment; or, for which care or treatment was given or recommended by a physician; or required the taking of prescription drugs or medicines, unless the condition for which the drugs or medicines are taken remains controlled without any change in the prescription drugs or medicines.

Pre-Existing Medical Condition Exclusion Waiver: If insurance was purchased within 15 calendar days of "initial trip payment", the Pre-Existing Medical Condition Exclusion will be waived. (Day one is the date the "initial trip payment" is received.) This is applicable to all coverages contained in the policy. In order to receive the waiver of Pre-Existing Conditions, the amount of Trip Cancellation coverage purchased must equal the full pre-paid non-refundable portions of all trip arrangements. The cost of any subsequent arrangement(s) added to the same trip must be insured within 15 days of the date of payment or deposit for any subsequent trip arrangement(s). Failure to do so may affect the pre-existing medical condition waiver coverage. You must be medically able to travel when you pay your plan cost. In the event that a claim is filed, the Injury or illness must be substantiated to our Claims Department. Applies to the first \$50,000 of trip cost per person.

Travel to sanctioned countries: Federal law prohibits unlicensed travel to sanctioned countries by U.S. citizens and permanent residents. Therefore, any expenses incurred or claims made related to travel to a sanctioned country are not covered under this plan, unless the insured is traveling under a license issued by the U.S. Department of Treasury Office of Foreign Asset Control.
